The personal data that will be processed for the purposes indicated below are specifically:

DATA RECIPIENTS OR CATEGORIES OF RECIPIENTS

RIGHTS OF THE PARTIES

In the cases provided for, the data subjects have the right to obtain access to their personal data and its rectification or cancellation, or the limitation of its processing or to oppose its processing (Articles 15 and subsequent amendments of EU Regulation 2016/679). Moreover, in the cases provided for, you have the right to data portability and in this case, the Data Controller will provide you with your personal data in a structured format, that is commonly used and readable, by an automatic device.

Interested parties who believe that the processing of personal data referred to them takes place in violation of the provisions of the Regulation have the right to lodge a complaint before the Supervisor Authority - Italian Guarantor (<https://www.garanteprivacy.it/>), as provided by art. 77 of the Regulation itself, or to refer to the appropriate judicial offices (art. 79 of the Regulation).
